Until this process has been completed the property will remain available for anyone to rent.

A. Each applicant must provide the following documents:

1. A completed application from each applicant 18 years or older.
2. A valid government issued photo identification card (drivers license, military ID, etc.)
3. A valid signature identification card (Social Security Card, credit card, check cashing card, etc.)
4. A copy of current pay stub or written verification of income. This is required for all income you list on your application.
5. Proof of current rabies vaccination (2 pet maximum)
6. Application processing fee. This fee is payable by CASH or MONEY ORDER ONLY.

The fees for application processing are: \$30.00 for one to two applications

We do NOT accept co-signers. \$45.00 for three applications

\$15.00 per application for four or more.

B. SUMMiT Properties and other outside agencies will verify ALL of the following:

1. That all ID's are valid
2. That there is combined household income of at least three (3) times the monthly rent.
3. Section 8 applicants only must show a combined household income of the lower of #2 above **OR**:
 - a. At least three (3) times their share of the monthly rent
 - b. **Plus** \$250.00 per person per month
4. That the required income has been continuous for the last six (6) months.
5. That the application is signed.
6. Good landlord references.
7. That the applicant has at least 70% good credit history.

C. Additional security deposit will be required if:

1. Income has not been continuous for at least 6 months.
 2. Good credit is less than 70% of all credit accounts.
 3. You have a pet (2 pet maximum)
- Liens, Judgments, and/or collection amounts exceeding \$300 are all grounds for denial.

D. Following approval of your application by SUMMiT Properties:

1. All parties must sign the Rental Lease Agreement.
2. The security Deposit must be paid in Cashier Check or Money Order.
3. The first full month's Rent must be paid prior to taking possession of the property. This payment must be made by CASHIER CHECK OR MONEY ORDER.
